Introduction

In 2019, the Capital Trust Agency received an unexpected \$450,000 for the extinguishment of a Land Use Restriction Agreement on a transaction that had been in default for years. The Agency did not anticipate recovery of any of its Annual Issuer's Fees at the time. In exchange for extinguishing the LURA, the Borrower paid the Agency the \$450,000 which was subsequently used to create the Capital Trust Agency Educational and Charitable Giving Fund.

The Agency Board of Directors set parameters for how this money would be spent; including approval of any spending from this account and placing a geographical limit on where the funds would be spent. To date, the Agency has provided more than \$200,000 toward qualifying 501c3s having access to students living in Gulf Breeze or attending Gulf Breeze schools.

This year, the Agency's Board of Directors set the Educational and Charitable Giving to \$60,000 within the City of Gulf Breeze and an additional \$30,000 of charitable giving.

Request

Take Stock in Children (TSIC) has made a request to the Agency board for a donation. Attached is a letter from the Student Services Coordinator, Monica Turner. From the Educational and Charitable Giving Fund, the Agency has given \$10,000 in each of the last three years. With Board approval, the Agency can do the same again this year. TSIC has committed to spending any donation from the Agency only on students attending Gulf Breeze schools.

Children's Home Society (CHS) of Florida has likewise requested \$10,000 from the Agency. Last year, the Agency gave \$10,000. Leah Harrison of CHS has provided the attached request letter highlighting how the Agency's giving affected Gulf Breeze and Santa Rosa families last year.

Dear Denis McKinnon and CTA Board.

A huge thank you to the CTA Board for your generous support of Children's Home Society in 2021 – you truly are impacting the lives of our communities in Gulf Breeze and Santa Rosa County. As an organization who has been in our community since 1920, Children's Home Society focusing on ensuring our children being able to reach their full potential. We do this through a variety of services to provide solutions and empower our children and families.

In the Gulf Breeze and Santa Rosa County area, we have children and families in services including our Youthworks, Adoption Support, Healthy Families and our Street Outreach/M-Power programming. Currently we are actively serving the following in Gulf Breeze:

- Two in Ashley Offerdahl Counseling trauma-informed care
- Five families in Adoption Support
- Two homeless youth in Street Outreach program
- 22 families in our Healthy Families including the siblings 55 served

Last year your gift allowed us to serve the following children and families in the Gulf Breeze area and here are a few updates on those programs. YouthWorks provides educational and employment services to youth between the ages of 16-24. Additionally, the Street Solutions Team -- which provides immediate assistance to runaway and youth experiencing homelessness, ages 14-22 in Escambia and Santa Rosa County, FL - continues to receive overwhelming referrals with more youth than ever literally living on the street. We have received calls from the Gulf Breeze and surrounding area for support services for our homeless youth. Our M-Power and Street Outreach provides housing and emergency shelter for these youth as well as medical and other client needs including utilities, work uniforms and basic needs (transportation, food, hygiene items, etc.). Next our Adoption Support program is focused on keeping families together and provide the supports they need. Many times, especially with children adopted out of foster care often experience unique challenges and situations that may arise due to histories of trauma, instability and boundary difficulties. As trauma can manifest in challenging behaviors, we provide family therapy, case management services and support groups to help maintain family stability. Lastly, our Healthy Families team also serves Gulf Breeze and in this program our focus is abuse prevention. In this program, parents receive encouragement, practical guidance, tools and resources in the comfort of their own homes as they partner with CHS to help their children realize their full potential. During voluntary weekly sessions, parents learn how to help their children reach key developmental milestones - and how to know if their child may be experiencing delays. Healthy Families also coaches overwhelmed parents on how to handle everyday stress, how to make their homes safe for infants and small children, and how to positively engage with their children, including the teaching of ageappropriate discipline. Among families that complete the program, nearly 100% remain free from abuse or neglect, and they also continue to pursue personal and family goals. Read Tanya's story below to see one of the families you impacted this past year.

Tanya's Story

When Tanya became pregnant with her first child she joined Children's Home Society of Florida's Healthy Families - a



program that provides encouragement, practical guidance and resources to parents throughout Western Florida. During weekly sessions, and in the comfort of their own homes, parents – like Tanya – learn how to help their children reach key developmental milestones so they can prepare to enter kindergarten ready to learn. Healthy Families also coaches overwhelmed parents on how to handle everyday stress, how to make their homes safe for infants and small children, and how to positively engage with their children, including the teaching of age-appropriate discipline. Tanya has disabilities





which make it difficult for her to access things like public transportation. She sought help from CHS to become more independent in making doctor appointments and helping her child succeed. Healthy Families helped Tanya organize consistent transportation and also helped her to recognize when her daughter was showing signs of developmental delays. Tanya's daughter, Bella, is now connected to additional support to help her overcome her challenges and realize her full potential. "Tanya is an all-around awesome mom," said Amber Scott, Tanya's Family Support Worker and a Supervisor with CHS. "She is a highly engaged parent doing everything she can to give her little girl the best life ever."
