Subject: Consideration of Support for Gulf Breeze High School Science Olympiad Team

Dear Board Members,

I am writing to request your consideration in providing financial support to the Gulf Breeze High School Science Olympiad Team. Leah Cochran, a science teacher at GBHS, has successfully restarted the team after more than a decade. Historically, this team has been a dominant force in state competitions, frequently advancing to the National Science Olympiad. Their return represents an exciting opportunity for local students to once again showcase their STEM talents on a broader stage.

The total cost for the team's participation this year is estimated at \$4,001.87 for 12 students. These expenses include:

- \$1,709.97 Science kits
- \$350.00 Team shirts
- \$432.96 Rental vans
- \$189.00 Gas
- \$1,320.00 Hotels

As Executive Director, I have the authority to allocate **\$500** from the Capital Trust Agency's budget. However, given the significance of this program and its impact on our local students, I would like to request the Board's consideration for providing additional financial support from the Educational Fund established to support students living in and going to school in Gulf Breeze. A contribution from CTA would directly enhance the students' ability to compete effectively while reinforcing our commitment to education and youth development in our community.
